 - a. Payment for service must accompany contract.
 - b. Incomplete contract forms will delay processing, please provide all information requested.
 - c. Location within the facility where the service is to be provided must be identified on face of form.
 - d. Orders/changes received within 3 days of event setup will be worked after other orders are complete.
3. Equipment Rented through Livewire (i.e modems, connection lines, etc.):
 - a. If not returned in condition it was given or at all, a \$129.95 fee will be collected
 - b. Clients should pick up rental equipment from the Mazda Raceway Laguna Seca (MRLS) IT Office.
 - c. The Client will be fully responsible for the protection and safekeeping of all rental equipment and will be responsible for returning all rental equipment to the MRLS IT Office by 5:00 p.m. the day following close of the event._____

6. Claims will not be considered unless filed in writing by Client prior to close of Event. _____
7. Any additional cost incurred by Livewire to:
 - a. Assist in trouble diagnosis or problem resolution found not to be the fault of Livewire
 - b. Collect information required to complete the installation that customer fails to provide may be billed to the Client at the prevailing rate of \$150 per hour._____
10. There will be a \$40.00 service charge for all returned checks. _____
11. The number(s) assigned to you are for the duration of this event only. Service cannot be moved or transferred outside of the Center and intercept service cannot be provided. _____
12. Prices are based upon current rates and are subject to change without notice. _____
13. Use of Network Connection:
 - a. The network attachment to be provided by Livewire may be used only by the directors, officers and employees of the company, its guests and its agents and consultants while performing service for the company and cannot be resold or distributed to other companies. The services being provided by Livewire will facilitate communications between the Company's authorized users and the entities reachable through the Internet. Users of Livewire services shall use reasonable efforts to promote efficient use of the networks to minimize, and avoid if possible, unnecessary network traffic, the transfer of large files and interference with the work of other users of the interconnected networks.
 - b. Users of Livewire services shall not disrupt any of the Livewire or other associated networks as a whole or any equipment of system forming part of their systems, or any services provided over, or in connection with any of Livewire or other associated networks. Livewire services shall not be used to transmit any communication where the meaning of the message, or it's transmit distribution, would violate any applicable law or regulation or would likely be highly offensive to the recipient or recipients thereof.

14. Wireless Specific: The use of any wireless device that interferes with the facility wireless data frequency is prohibited. _____
15. Internet Performance Disclaimer: Livewire does not guarantee the performance, routing, or throughput, either expressed or implied, of any data circuit(s) connectivity with regards to the Internet and/or Internet backbones beyond any facility we service. _____

17. VIRUS PROTECTION REQUIREMENT – WARNING – Livewire requires that all devices directly or indirectly accessing MAzda Raceway’s Network have the latest virus scan software, windows security updates, system patches, and any other technological precautions necessary to protect yourself and others from viruses, malicious programs and other disruptive applications. Any device, which adversely impacts Livewire’s Network, will be disconnected from the network with or without prior notice at Livewire’s discretion. The device(s) in question will remain disconnected from the network until all issues are proven to be adequately resolved. Additional charges will apply at the prevailing rate of \$150 per hour for trouble diagnosis and/or problem resolution. _____
18. The choice of Internet Service Provider (ISP) is at the sole discretion of Livewire. _____
19. CANCELLATION - There is a minimum \$500 Cancellation fee. Cancellations must be in writing. Additional cancellation charges will apply for orders that have already incurred labor, material, and / or engineering costs. Some broadband services and special circuits cannot be cancelled once ordered and will incur full charges listed / quoted. Credit will not be given for service installed and not used. _____

LIMITATION OF LIABILITY

Mazda Raceway Laguna Seca and Livewire Information Systems, its suppliers or subcontractors will not be liable for any special or consequential damages, or for loss, damage or expense directly or indirectly arising from customer’s use or inability to use the system either separately or in combination with other equipment or software, or for commercial loss of any kind (including loss of business profits) based upon breach of warranty, breach of contract, negligence, strict tort or any other legal theory whether or not Livewire or its suppliers or its subcontractors have been advised of the possibility of such damage or loss. In no event shall liability exceed a refund of amounts actually paid to Livewire by company for their network attachment.
